

## **Deepwater Horizon Trustee Council Annual Financial Summary Report**

(Cumulative through December 31, 2016)

## **Report Overview:**

The Deepwater Horizon natural resource damage assessment settlement mandates annual payments over a 15-year period. The payments total \$8.8 billion, for use by the state and federal trustees for restoration planning and implementation. This annual report details the status of the receipt, allocation, and expenditure of funds through December 31, 2016. The terms used in this report are defined as follows:

- Funds Received Funds received from BP and any interest earned on those on funds.
- Allocated Funds that have been transferred to an implementing trustee for the purposes of restoration activities.
- Unallocated Funds that have not yet been allocated to a specific restoration activity.
- **Expended** Allocated funds that have been paid out by the implementing trustees for restoration activities.
- **Unexpended** Allocated funds that have not yet been paid out.
