Deepwater Horizon Trustees Invite Public Comment on

Proposed Florida Coastal Access Early Restoration Gulf Project

Public Meeting on December 14 in Panama City; Comment Period Open through December 31

Gulf Coast (December 1, 2015)-----The *Deepwater Horizon* oil spill Natural Resource Damage Assessment Trustees released a draft plan today that proposes a Florida Coastal Access restoration project at an estimated cost of \$34.4 million.

The Draft Phase V Early Restoration Plan and Environmental Assessment is available for public review and comment through December 31. It is posted online at [www.gulfspillrestoration.noaa.gov](http://www.gulfspillrestoration.noaa.gov) and will be available at a public meeting held on December 14, 2015.

The public meeting will begin with a 30-minute interactive open house (at 6:00 PM) where Trustee staff will be available to discuss project details. The open house will be followed by a formal presentation (at 6:30 PM) and opportunity for the public to provide comments to Trustee representatives.

The proposed Florida Coastal Access Project would enhance public access to the surrounding natural resources and increase recreational opportunities through the acquisition and/or enhancement of four coastal parcels in the Florida Panhandle. These locations include Innerarity Point in Escambia County, a parcel in the City of Destin, a parcel in the City of Lynn Haven, and Island View Park in Franklin County. The proposal also includes funding for ten years of operation and maintenance.

A future phase of this project will propose acquisition of one or more additional properties in the Florida Panhandle to provide passive recreational uses and coastal access for the public. This future phase would also include ten years of funding for operation and maintenance.

Early restoration allows the Trustees to jump-start restoration using up to \$1 billion BP has agreed to make available for projects jointly agreed to by BP and the Trustees. If the proposed Phase V project is approved, approximately \$866 million of the \$1 billion would be obligated.
