

RECENT ACTIVITIES

In the past year, we have been busy overseeing the continued engineering, design, construction, and monitoring of early restoration projects. In March 2019, we released Final Restoration Plan 1 which approved 23 projects for a total estimated cost of \$61 million. In September 2019, we approved Phase V.3 Florida Coastal Access Project selecting one project for an estimated cost of \$2 million.

WHAT WE DO


